The quotations shall be opened on the same day at 3.30 PM in the office of the Commission. Interested firms may, if they so desire, attend themselves or send their authorized representatives at the time of opening the quotations.
- CA firms shall be awarded the Internal Audit of the Annual Accounts of the Commission and filing of Annual Income Tax return initially for FY 2018-19 and FY 2019-20 extendible further based on performance of the firm.
- 3. The bid amount is inclusive of professional fees, TA/DA, local conveyance, lodging & boarding etc. except GST/applicable taxes. No other payment shall be made except quoted by the firm. The payment shall be released after acceptance of the report by the Competent Authority.
- 4. **Terms of Payment**: The 25% payment will be released after approval of the Internal Audit report by the competent Authority and rest on filing of annual Income Tax return. The firm must quote GST number in the bill / invoice.
- 5. Commission reserves to itself the right to reject the conditional tenders without assigning any reason thereto.
