Interested firms may, if they so desire, attend themselves or send their authorized representatives at the time of opening the quotations.
2. Prices must be quoted strictly in the format given at Annexure-A in this document and prices shall be firm and no escalation on account of labour or material or any other reason what so ever, will be paid to contractor for execution of work.
3. Tenders are requested to visit the site and get themselves fully acquainted with the nature and quality of work and get clarifications about the job from PPS/PA to Chairperson of JERC before submitting the offer.

4. The firm will be responsible for the quality of the material supplied and workmanship and it will be guaranteed for a period of two years from the date of completion of job. Guarantee for items such as LED Tube lights and similar branded items like LED module etc. associated directly to the lighting system shall be as per the guarantee provided by the respective company if its more than 2 (two) years.
5. The firm shall have to enclosed a demand draft of Rs.25,000/- as earnest money in favour of Secretary, Joint Electricity Regulatory Commission, Gurugram which will be returned to the unsuccessful bidders, after finalization of the contract. EMD of the successful bidders shall also be released on furnishing 10% performance security of the order value in the form of performance bank guarantee.
