## INTERIM ORDER

The Commission heard the Ld Counsel for the Petitioner at length. The Commission also heard the Ld Counsel for the Respondent.

The Commission raised the following queries:

- (i) The stand of the Electricity Department A&N Islands on the electricity tariff that should have been charged from the Hotels who were registered as Industry by the MSME department for the period from FY 2012-13 to FY 2021-22.
- (ii) The month wise details of the billing of the Petitioner calculated as per Commercial Tariff and Industrial Tariff and the amount actually paid by the Petitioner for FY 2019-20 to FY 2021-22.

The Respondent requested the Commission to grant three weeks time to file the said additional information on affidavit. The Commission grants the liberty to Respondent to file said additional information on affidavit duly approved by the Competent Authority and signed by Director (Power)/ Secretary (Power) of UT Administration of A&N Islands with an advance copy to the petitioner.

The petitioner is also directed to file its rejoinder, if any, within two weeks from the date of receipt of the copy of the affidavit of the Respondent.
