ORDER

The Commission heard the Petitioner and the Respondent on 17.11.2016 and directed them to submit the requisite documents positively by 21.11.2016 (F/n).

The Commission again heard the matter on 24.11.2016 and agreed to the request of the Petitioner to extend the time for furnishing of information / documents as required by the Commission by 25.11.2016. Both the parties also agreed to submit a mutually reconciled statement by 26.11.2016 showing the total amount received by the Petitioner.

The Commission noticed that there is no compliance of the aforesaid Orders of the Commission by the Petitioner.


The Commission received an e-mail dated 25.11.2016 from the Petitioner again seeking extension of time by two weeks for submitting the requisite documents and explanation.

The Commission takes a serious view of the conduct of the Petitioner and feels that delay in adjudicating this pending matter as per the Hon'ble Supreme Court's Order dated 18.10.2016 is due to non submission of relevant documents on the part of the Petitioner. The Commission accepts the request of the Petitioner for grant of two more weeks time to file the requisite relevant documents and explanation and directs the Petitioner to file all the requisite documents and explanation with a copy to the Respondent. The Respondent shall reply to the submission of the Petitioner within a week. Further both the Parties are directed to submit a jointly reconciled "Drawn" statement duly signed by both the parties as a last and final opportunity, failing which the Commission shall be constrained to decide this pending Petition on the basis of documents and information available with it.
