The petitioner - M/s. Perfect Filaments Ltd. has filed the present petition under Section 62 (6) of the Electricity Act, 2003 for recovery of excess amount of Rs. 4,82,213/- in flagrant disregard to Electricity Act, 2003 as well as Rules and Regulations framed time to time by the Commission.

The petition was received in the Commission on 10.09.2014. The Commission examined the petition and found it technically in line with the JERC (Conduct of Business) Regulations, 2009 and Electricity Act, 2003. The Commission admitted the petition on 15.09.2014.

The Commission sent hearing notice to the parties for 13.11.2014. Counsel for the petitioner and representative of the respondent ED- Daman & Diu appeared on 13.11.2014. Counsel for the petitioner explained salient features of the petition. The Commission heard the Counsel for the petitioner and representative of the respondent.

On 13.11.2014 the representative of the respondent prayed for one month for filing reply of the petition on the ground that they had not received copy of the petition. The Commission considered the prayer of the representative of the respondent and acceded the same. The Commission directed the respondent to file reply within three weeks with advance copy to the petitioner. The Commission also directed the petitioner to file rejoinder, if any, on or before 17.12.2014.

Counsel for the respondent submitted that copy of the petition has not been received by the respondent, therefore, he is unable to file reply. Therefore, the petitioner is directed to supply copy of the petition to Counsel for the respondent within a week against proper receipt. The respondent is also directed to file reply on or before 15.01.2015.
