The representative of ED- Puducherry explained salient features of the Application & Agreement Form (A&A) for LT/HT connections. The Commission also heard representative of the respondent.



Therefore, till finalization/ notification of the proposed amendments the licensees shall use their existing Application & Agreement Form (A&A) for LT/HT connections.
